Re: 2014-2015 Long Track Skating

TCSS is offering supervised long track skating sessions at the Roseville Oval. The coached TCSS sessions are on Thursday nights. Attached are the forms and waivers for skating long track this season.

For safety reasons, the long track program will only be available for Silver/Gold team skaters. However, we do plan to host a few long track open skating opportunities for all TCSS skaters about once a month at The Oval.

When: Thursdays, November 13, 2014 through February 26, 2015 (15 sessions)

Holiday weeks - switch to Tuesday, December 23 and Tuesday, Dec. 30

Time: 7:00-8:30 p.m.

Cost: \$290 (\$240 ice/\$50 coaching)

Coaching: Long track coaching will be provided by Melissa Dahlmann. Steve Miller, Susan Sandvig-Shobe,

Greg Oly and Anthony Christie will also be assisting throughout the season.

If skaters would like to participate in long track weekend time trials/pack racing, there will be a weekly signup at The Oval and \$20 per day of racing will be collected directly by GMSA on the day of the race.

Want to skate at The Oval more than 1x/week? Below is a summary of the skate plans offered.

Membership Fee for Twin Cities Speedskating: \$25 (short track members do not need to pay this again)

PLUS

Full Ice: \$600 + \$25 if TCSS membership is needed (\$550 ice/\$50 for Thursday TCSS coaching)

<u>Partial Ice:</u> \$450 + \$25 if TCSS membership is needed (\$400 ice/\$50 for Thursday TCSS coaching)

Skater can attend 25 GMSA contracted practice ice sessions at The Oval. In addition to the TCSS Thursday night
